

You Belong/Adventure Zone Private Party Rental

When can I host an event?

- All reservations MUST be made at least 14 days prior to the event
- Private party rental time are in 3 hours blocks.

What space is available to your party?

- When you rent at You Belong you are given the full facility to privately use for you and your party members. This is 6,000 square feet of fun including:

The Adventure Zone – Sensory Maze, Dinosaur Excavation, Animal Tree House, Wilderness Adventures, and little's Adventures

Sensory Room – Underwater Exploration

Classroom – imagination play and small motor skills

Multi-Purpose Room – food tables and comfy massage chairs

RENTAL FEE AND PAYMENT TERMS:

Rental Fee:

Family Class or Annual Member - \$300 (3-hour private rental)

Others - \$350 (3-hour private rental)

Security Deposit: \$50 at time of reservation (will count towards overall cost)

Due Dates: Full amount due prior to event

Payment Method:

Credit/debit card, bank draft, check or cash

DURATION OF RENTAL:

Start and End Time: 3-hour reservation time block

Fridays 4:00pm-7:00pm

Saturdays 1:00pm – 4:00pm OR 4:30pm- 7:30pm

Sundays 10:00am - 1:00pm OR 1:30pm – 4:30pm

CANCELLATION POLICY:

In the event of cancellation, the following policies apply:

Cancelation prior to 14 days of the event - \$50 deposit is returned in full

Cancelation within 14 days of the event - \$50 deposit is not returned

USE OF THE VENUE:

Lessee agrees to use the venue solely for the purpose of hosting the private party on the specified date.

- Lessee is permitted to bring in their own food for their private event

- Lessee is permitted to bring in their own decorations for their private event with the exclusion of: glitter, confetti, latex balloons, and piñatas.

- Lessee agrees to remove all decorations and food by the end time of event
- Any damage that occurs to You Belong property during the event may be charged to Lessee

Restrictions:

- Lessee does NOT have access to kitchen space unless arranged prior to the event with You Belong staff.

LIABILITY:

- Both parties agree to indemnify and hold each other harmless from any claims arising out of the event.
- Hosts are responsible for all members of their parties. **If children are dropped off by parent/legal guardian, party host assumes FULL responsibility of child

TERMINATION CLAUSE:

- Either party may terminate this Agreement in writing if the other party breaches any material terms.
